V. Zoning Bylaw Updates

(a) Solar screening ordinance/bylaw & draft Enhanced Energy Plan

Discussion on proposed town sites for future preferred solar installations as a component of Weathersfield's Enhanced Energy Plan. Sven Fedorow cited the ongoing legal battles in Bennington involving large solar arrays and town/resident opposition to certain locations. Weathersfield has been asked to provide suitable sites for solar arrays and other energy systems to meet the future Department of Public Service Municipal Enhanced Energy Planning Standards.

Sven Fedorow drew up a list of considerations and commitments for Weathersfield contained on the draft plan. Following discussion it was agreed that the Planning Commission should consult with the selectboard regarding suggestions to hold a series of, maybe, three open 'question and answer' meetings around town so townspeople could participate. These would be advertised in local and social media.

Jason Rasmussen, Senior Planner at SWCRPC will attend the next Planning Commission meeting on February 28, 2019 to talk about his expertise on passing the Regional Energy Plan. Sven Fedorow will prepare a onepage sheet with questions for Jason Rasmussen and ideas for Weathersfield's plan. He will also prepare a draft for the selectboard with a synopsis of the Town Plan, solar installations and the need to get people's opinions before the town proceeds with its approval.
