RE: Vote to set the FY24 Property Tax Rate

Dear Selectboard Members,

Our total listed value increased from \$345,492,388 in FY23 to \$346,685,131 in FY24. The total increase was \$1,192,743 OR .34%. GMP utility went down by 990,000, VELCO went down by 826,000. We added \$3M from permit work. There was a \$250K loss as compared to last year's personal property inventory, but a few had an increase in their overall inventory, so the Personal Property nets out to an increase of \$80K.

The Homestead Tax Rate decreased from 1.7941 in FY23 to 1.6646 in FY24. The Non homestead Tax Rate increased from 1.6680 in FY23 to 1.7179 in FY24. Last year each penny on the grand list was \$33,189.36, and this increased to \$34,333.71 in FY24.

The Municipal Tax Rate in FY23 was 0.6269, and the Municipal Tax Rate in FY24 will be 0.6843, OR 0.0574 higher than FY23 (+9.2%). When we developed the estimated tax rate for FY24 (based on the FY23 Grand List), we estimated a 0.0717 increase (+11.1%).

Additionally, when we estimated the Municipal Tax Rate in FY24 (based on the FY23 Grand List), we estimated a \$72 increase in Municipal Taxes on a \$100,000 house (without Education taxes). The increase on a \$100,000 house based on the updated Grand List is \$57 (without Education taxes).

Local education taxes have increased. Last year there were 19 homestead and 10 non homestead exemptions. This year there are 32 homestead and 7 non homestead exemptions.
